Award is for the Author/s only. The Author/s shall be citizens of India. The publication shall be published by the publishers from within the geographical domain of India. This award is for the Author/s for Book/s in the domain of Civil Engineering, considered to be useful to Civil Engineering Consultants for their day to day practice/reference. It is mandatory that the published work should have been an original work of the Author/s, the proof for which shall be submitted in the form a relevant ISBN number. The publication should have been published within the time frame as applicable for ACCE(I) AWARDS 2019. The publication shall be specific to the domain of Civil Engineering, and shall not be text books written to any specified syllabus of any University. Individuals filing nominations shall attach a copy of the letter of consent for submission for the Award from the Publishers along with the form.

The Publication should have been published in a time frame, which shall not be more than 3 years old as on closing date of filing nomination.

The criteria for selection for this award shall be based on the following by giving appropriate weightage for all/some of the following, the discretion for which shall rest with the jury duly constituted for the purpose:

1. The Author/s shall be a Citizen of India.
2. The book shall be published within the geographical domain of India.
3. Nomination shall be for a Book related strictly to the domain of Civil Engineering, but excluding Text Books.
4. Alternatives considered and the reasoning for the selection of the adopted topic.
5. Relevance of the topic of the book.
6. Effective usage of available literature to achieve the desired results.
7. Effective usage of technology for systematic transfer of thought process.
8. Development of a new system of presentation resulting in patenting the same.
9. Innovation in content presentation,
10. Graphical representation of the concepts in the presentation.
11. Interactive multimedia kit for a better understanding.
